Acceptable forms of ID include:

- Florida driver's license
- Florida identification card issued by Department of Highway Safety and Motor Vehicles
- United States Passport
- Debit or credit card
- Military ID
- Student ID
- Retirement Center ID
- Neighborhood Association ID
- Public Assistance ID

Florida law requires that a voter present current and valid picture and signature identification when voting in person. Any voter appearing to vote without identification will be allowed to vote a Provisional Ballot.

If you vote by mail, the signature we have on file for you may need to be updated.

Signatures can change over time. Election officials are required to verify the signature on your vote-by-mail envelope with the signature in our voter registration database. If your signature has changed, now is the time to make sure an updated signature is on file.
