Voter Eligibility: You are eligible to register to vote if you are a U.S. citizen, age 18 or older, and a legal resident of the county in which you are registering. You may pre-register to vote if you are 16 or 17 years old and if you do, you will automatically be registered to vote on your 18th birthday.

**General Information** 

Florida's Closed Primary Elections: If all candidates for an office have the same party affiliation and the winner of the primary will have no opposition in the general election, all eligible voters, regardless of party affiliation, may vote in the primary election for that office. Otherwise, the primary is closed, and only voters registered with a political party may vote in that party's primary.

Sunshine Law requires that all meetings at which decisions about public business are made, including those of the Florida Legislature, be open to the public. The Florida Open Records Law requires that the files of all public agencies be open for public inspection.
