Acceptable forms of ID include:

- Florida driver's license
- Florida identification card issued by Department of Highway Safety and Motor Vehicles
- United States Passport
- Debit or credit card
- Military ID
- Student ID
- Retirement Center ID
- Neighborhood Association ID
- Public Assistance ID
- Veteran Health ID card issued by the U.S. Department of Veterans Affairs
- License to carry a concealed weapon or firearm issued pursuant to section 790.06, Fla. Stat.
- Employee ID card issued by any branch, department, agency, or entity of the Federal Government, the state, county, or a municipality

Florida law requires that a voter present current and valid picture and signature identification when voting in person. Any voter appearing to vote without identification will be allowed to vote a Provisional Ballot.

 **UPDATE OF VOTER'S SIGNATURE** 

It is very important for you to keep your signature current with the Supervisor of Elections. Signatures on your registration record are used to verify signatures on petitions, Vote-By-Mail ballots and provisional ballots. If at any point there is a significant change in your signature, use a Florida Voter Registration Application to update your signature.

State and local governments shall retain their abilities to protect consumer rights and public health, safety and welfare, and to ensure that consumers who do not choose to install solar are not required to subsidize the costs of backup power and electric grid access to those who do. The amendment is not expected to result in an increase or decrease in any revenues or costs to state and local government. <input type="radio"/> Yes <input type="radio"/> No	Tax Exemption for Totally and Permanently Disabled First Responders Proposing an amendment to the State Constitution to authorize a first responder, who is totally and permanently disabled as a result of injuries sustained in the line of duty, to receive relief from ad valorem taxes assessed on homestead property, if authorized by general law. Polston of the Supreme Court be retained in office? <input type="radio"/> Yes <input type="radio"/> No	School Board Member, District 2 (Vote for One)	No. 2 Constitutional Amendment Article X, Section 29 Use of Marijuana for Debilitating Medical Conditions Allows medical use of marijuana for individuals with debilitating medical conditions as determined by a licensed Florida physician. Allows caregivers to assist patients' medical use of marijuana. The Department of Health shall register and regulate centers that produce and distribute marijuana for medical purposes and shall issue identification cards to patients and caregivers. Applies only to Florida law. Does not immunize violations of federal law or any non-medical use, possession or production of marijuana. Increased costs from this amendment to state and local governments cannot be determined. There will be additional regulatory costs and enforcement activities associated with the production, sale, use and possession of medical marijuana. Fees may offset some of the regulatory costs. Sales tax will likely apply to most purchases, resulting in a substantial increase in state and local government revenues that cannot be determined precisely. The impact on property tax revenues cannot be determined. <input type="radio"/> Yes <input type="radio"/> No	No. 5 Constitutional Amendment Article VII, Section 6 Article XII Homestead Tax Exemption for Certain Senior, Low-Income, Long-Term Residents; Determination of Just Value Proposing an amendment to the State Constitution to revise the homestead tax exemption that may be granted by counties or municipalities for property with just value less than \$250,000 owned by certain senior, low-income, long-term residents to specify that just value is determined in the first tax year the owner applies and is eligible for the exemption.
